MAREP Report: Yvonne Barbour

Lake Erie, the smallest and the shallowest of all the Great Lakes, has a lake retention cycle of 2.6 years. What this means is that the lake water is renewed in less than three years by the flow of water from upstream sources.

Lake levels fluctuate month to month, day to day and hour by hour. Month to month levels are generally highest in October and November, this year being an exception. Hour to hour fluctuation are mostly due to the effects of the wind, prevailing winds from the west push up the level in the east part of the lake while lowering the level in the west end. Wind surges can be significant with rapid changes of more the 1.5 feet being recorded.

On February 4th at 7:00 P.M. Lake Erie's water level was .347 meters above chart datum. This level is well below the average level but not yet to the concern levels of Lakes Huron and Michigan which are at record low levels. Great Lakes water levels began a steep decline in the late 1990's, scientist's support the theory that weather is the largest factor, critics are skeptical and believe that man has been a negative influence.

The ice is going out, spring and boating season can't be far behind. See you on the water. Fair winds and safe boating for the upcoming season.

The Royal Canadian Mounted Police & United States Coast Guard are now permanently working together to strengthen marine security on our shared waterways. This unparalleled North American security arrangement, known informally as Canada-U.S. "Shiprider" has been piloted and evaluated since 2005 and became law in 2012.

Anyone on the waterways, particularly near the international maritime boundary, could encounter an RCMP or USCG vessel which – and this is key- is crewed with both RCMP and USCG officers.


When in Canadian waters, it is always a Canadian law enforcement officer in charge. However, the U.S. law enforcement officer can enforce Canadian laws under the control and direction of the Canadian officer. It is the reverse arrangement in U.S. water. American officers are in charge, but their Canadian partners can enforce American laws under the control and direction of the American officer. This partnership fully respects the sovereignty and the rights of the citizens of both countries and in no way diminishes Canadian sovereignty or cedes enforcement authority to U.S. law enforcement officers.

Officers from Canadian and U.S. law enforcement agencies are required to undergo joint training in order to participate in the Canada-U.S. Shiprider operations. This mandatory training includes completion of in-class seminars, case-study scenarios, as well as acquiring an understanding of the criminal laws, privacy laws and policies of both Canada and the U.S.

Shiprider could be activated in shared waterways including the Great Lakes and the East and West coasts. It may also be deployed during major international event.

Canada-U.S. Shiprider is a modern and innovative solution to targeting criminal activities on the waterways shared between our two countries. The Shiprider model, whereby officers have official cross-designated status, removes the international maritime boundary as a barrier to law enforcement. Having a representative from a Canadian and American law enforcement agency on the same vessel allows for a seamless continuity of enforcement and security operations to travel back and forth across the border. The reciprocal arrangement permits cross-border surveillance and interdiction that otherwise would not be possible.

RVCC Report

The purpose of the RVCC Program is to help boaters ensure that their vessel, no matter what it's size, has on board all the minimum safety items required by law and to help promote the Squadrons goal of boating safety through education. The RVCC program is not in any way an "enforcement" tool, there is absolutely no interaction between the courtesy inspectors and the "Boys In Blue". The owners name, and the boats name are not recorded, exchange of names at the onset is only done to be courteous.

Your assistance is appreciated in encouraging your marina to host a RVCC day, it only takes about ten to fifteen minutes to complete each boat, there is no cost for the checks. Ask your marina to welcome the RVCC Program, spin off sales of basic missing items make for safer boaters and enhance sales at the marina's chandlery. Doug, Yvonne and I are hopeful that we will be able to perform a greater number of Recreational Vessel Courtesy Checks (RVCC) this summer. See you for your Courtesy Check.

History of Navigation

This is the historical era of the Phoenicians and their successors the Carthaginians. These navigators were particularly able and adept sailors and learned to voyage further and further away from the coast in order to reach their destinations faster. One tool that helped them was the sounding weight. This tool was bell shaped made from stone or lead with tallow inside, attached to a long rope. When out to sea, sailors could lower the sounding weight in order to determine how deep the waters were, and therefore estimate how far they were

from land. In addition the tallow picked up sediments from the bottom, which expert sailors could examine to determine almost exactly where they were.

The Carthaginian, Hanno the Navigator is known to have sailed through the Strait of Gibraltar C. 500 B.C. and explored the Atlantic Coast of Africa. There is a general consensus the expedition reached at least as far as Senegal. There is a lack of agreement whether the furthest limit of Hanno's explorations was Mount Cameroon, or Guinea's 890 meter (2910 foot) Mount Kakulima. One may wonder how these facts are known. It must be understood that these people already had the ability to record their happenings and events with a written text.

In the South China Sea and the Indian Ocean, a navigator at that time could take advantage of the fairly constant monsoon winds to judge direction. The earliest known reference to an organization devoted to ships in ancient India is to the Maurian Empire from the 4th century BCE. The Arthashastra of Emporer Chandragupta Maurya's prime minister, Kautilia, devotes a full chapter on the state department of water ways under a navadhyaksha, (which is Sanskrit for "Superintendent of Ships". The term, nava dvipantaragamanam, Sanskrit for sailing to other lands by ships, appears in this book in addition to appearing in the Buddist text, Vaudhayana Dharmasastra.

Before you know it, this article will render you to speak perfect Sanskrit. The next time we will be drifting into Medieval Age of Navigation.
